NOW THEREFORE, if Contractor shall in all particulars promptly and faithfully perform each and every covenant, condition, and part of the Project in accordance with the terms of Ordinance 4405, codified in the Lenexa City Code at Article 4-1-N, Land Disturbance Provisions, then this obligation shall be and become null and void; otherwise it shall remain in full force and effect.

Provided further that if Contractor fails to perform and abide by any such obligations hereunder in any respect, the Surety shall either promptly remedy such failure to the satisfaction of the City or shall within fourteen (14) days from the date of written notice from the City pay to City sufficient funds to pay the cost of such compliance and other costs and damages for which the Surety may be liable hereunder.

The Surety, for value received, hereby stipulates and agrees that no change, extension of time, alteration, or addition to the terms of the permit, or applicable ordinance shall in any way affect its obligations on this Performance Bond and it does hereby waive notice of any change, extension of time, alteration, or addition to the terms of the permit or ordinance.
